**Re: Brexit Related Terminal Services from 01.01.2021 onwards.**

Dear Customer,

Following previous Brexit correspondence, we are conscious that the obligations imposed to C.RO / CLDN by various authorities will require the terminals to perform additional services, some of them, which are not provisioned for under the current Terminal Tariffs. These services will most likely be dynamic in the coming months immediately following Brexit. We have therefore opted to consolidate the services and their pricing in a separate rate sheet also offering suitable guidance where needed.
